**Witness that,**

- I. Missouri University of Science and Technology, in consideration of the payment and undertakings hereinafter agreed to be made and performed by the Student, hereby agrees to furnish the Student board (meal service), for that part of the Fall and Spring Semester during which Missouri S&T is in session, from August 17, 2024 through brunch on May 16, 2025.
- II. The Student agrees to pay Missouri S&T for the board herein contracted for, the 2024-2025 academic year.
- III. It is mutually agreed by and between the parties hereto, as follows:
  - a. The sum hereinabove agreed to be paid may be changed by Missouri S&T in the event of a fluctuation in costs and, after notice of change, will be immediately paid, and
  - b. The right and privilege is reserved to, and by, Missouri S&T, to discontinue the board service herein provided for, in the event of epidemic, or other urgent cause which may necessitate the use of the cafeteria for a purpose other than dining, or which may cause the congregating together of students in large numbers to be considered unsafe from the standpoint of health, and
  - c. This agreement is personal to the parties hereto and shall not be transferred or assigned, either in whole or part, by either Missouri S&T, and
  - d. The Student will in all respects comply with all of Missouri S&T rules and regulations relative to the facilities mentioned above, which are now, or hereafter may be, in effect, which rules and regulations are specifically made a part hereof with like effect as though set forth herein, and
  - e. Refunds on payments for the meals at the cafeteria will be made only in cases when an absence from classes has been authorized. Commencing on the sixth day, refunds on the daily charge will be refunded, provided that such absences have been authorized as stated below. Absences not properly excused will not be refunded. **NO REFUNDS** will be made for the first five days of the EXCUSED ABSENCE.
    - i. ABSENCE CONNECTED to a University field trip or other class assignment must be verified in writing by the instructor. The verification must be presented to the Office of Residential Life in advance of the scheduled absence.
    - ii. ABSENCE DUE TO ILLNESS OR PERSONAL TRAGEDY which exceeds five days will be refunded, provided that the Office of Residential Life is notified during the five days of an absence by the Student or by a member of the Student's family.

1. This agreement is for the Academic year 2024-2025. You may request to be released from this agreement at the end of the Fall Semester. HOWEVER, all meals and declining balances remaining on your account will be lost. Request must be written and submitted to Residential Life, 1102 N. Rolla St., **no later than January 31, 2025.**
2. A valid ID will be required. The University reserves the right to require board students to have an unaltered, unobstructed, legible one-piece student identification card.
3. The University reserves the right to limit access to certain cafeterias during assigned holiday breaks and weekends.
4. Meals are served as follows: Monday through Friday-breakfast, lunch and dinner. Saturday and Sunday-brunch and dinner. For exceptions, please see the Residential Life Housing & Food Service Calendar
5. This contract will expire on May 16, 2025. All unused meals and declining balances will be lost if not used.
